

ORDINANCE NO. 505

AN ORDINANCE OF THE TOWN OF INDIAN RIVER SHORES, FLORIDA SETTING TERM LIMITS AND ATTENDANCE STANDARDS FOR CERTAIN BOARDS; AMENDING SECTION 30.33 RELATING TO THE PLANNING, ZONING AND VARIANCE BOARD; AMENDING SECTION 30.81 RELATING TO THE CODE ENFORCEMENT BOARD; AMENDING THAT PORTION OF THE TOWN OF INDIAN RIVER SHORES PUBLIC SAFETY OFFICERS AND FIREFIGHTERS' DEFINED BENEFIT PLAN RELATING TO COUNCIL APPOINTEES TO THE BOARD OF TRUSTEES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council has determined that there should be attendance standards for members of boards of the Town; and

WHEREAS, the Town Council has determined that there should be term limits for consecutive service on boards;

NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF INDIAN RIVER SHORES, FLORIDA, HEREBY ORDAINS:

Section 1: PLANNING, ZONING & VARIANCE BOARD.

Section 30.33. Terms; meetings, of the Town Code of Ordinances is amended to add subparagraphs (b) and (d) and renumbering former subparagraph (b) as (c) as follows:

(b) A member* may serve for two (2) consecutive four-year terms only.

(b c) Meetings of the planning board shall be held at least once prior to each regular town council meeting. The meeting shall be held at the town hall. Minutes shall be kept of all meetings. (1978 Code, § 2.26; Ord. No. 176, 3-31-77; Ord. No. 3378, 3-27-86)

(d) Any member* of the Board with unexcused absences for two (2) of three (3) successive meetings shall be subject to removal by action of the Town Council. The Chairman of this Board may grant an excused meeting upon request of a member made prior to the meeting to be missed.

Section 2: CODE ENFORCEMENT BOARD.

Section 30.81. Composition; terms of office, is amended to add subparagraphs (b) and (c) as follows:

(b) Any member* of the Board with unexcused absences for two (2) of three (3) successive meetings shall be subject to removal by action of the Town Council. The Chairman of this Board may grant an excused meeting upon request of a member made

prior to the meeting to be missed.

(c) A member* may serve for two (2) consecutive three (3)-year terms only.

Section 3. TOWN OF INDIAN RIVER SHORES PUBLIC SAFETY OFFICERS & FIREFIGHTERS' DEFINED BENEFIT PLAN.

The adopted plan is amended to add the following language:

As to the two (2) appointees of the Town Council, should a Town Council appointee have unexcused absences for two (2) of three (3) successive meetings, he or she shall be subject to removal by vote of the Town Council. The Town Council may excuse an appointee from attendance at a Pension Board meeting upon request of the appointee seeking to be absent.

Section 4. REPEAL.

All Ordinances or parts of Ordinances in conflict herewith or inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

Section 5: EFFECTIVITY.

This Ordinance shall become effective immediately upon its passage and adoption by the Town Council of the Town of Indian River Shores, Florida.


