SCHEDULE "A" - BUILDING PERMIT FEES

AT TIME OF APPLICATION, ONE HALF OF THE TOTAL BUILDING FEE AND PLAN CHECKING FEE MUST BE PAID. IF PLANS ARE APPROVED, THE AMOUNT WILL BE CREDITED TOWARD THE BUILDING PERMIT. IF PLANS ARE NOT APPROVED OR THE PERMIT IS CANCELLED, THE FIFTY PERCENT IS FORFEITED. BALANCE DUE WHEN PERMIT IS ISSUED.

A PLAN IS REQUIRED TO BE SUBMITTED BY FBC 104.2. PLAN CHECKING FEE SHALL BE PAID TO THE BUILDING OFFICIAL AT THE TIME OF SUBMITTING PLANS AND SPECIFICATIONS FOR CHECKING. PLAN CHECKING FEE SHALL BE EQUAL TO ONE-HALF OF THE BUILDING PERMIT FEE AS SET FORTH IN 104.6. SUCH PLAN CHECKING FEE IS IN ADDITION TO THE PERMIT FEE.

****FEES DOUBLED FOR WORK STARTED WITHOUT PERMIT.**

THE FOLLOWING FEES BASED ON THE TOTAL COST OF NEW CONSTRUCTION, ADDITIONS, ALTERATIONS AND REPAIRS.

\$1,000 or less – Minimum Fee all permits-\$60.00

\$1,001 to \$50,000 - \$19.80 for the first \$1,000 plus \$6.60 for each additional thousand or fraction thereof, up to and including \$50,000.

\$50,001 to \$100,000 - \$343.20 for the first \$50,000 plus \$5.30 for each additional thousand or fraction thereof, up to and including \$100,000.

\$100,001 to \$500,000 - \$608.20 for the first \$100,000 plus \$4.00 for each additional thousand or fraction thereof, up to and including \$500,000.

\$500,001 and UP - \$2208.20 for the first \$500,000 plus \$2.70 for each additional thousand or fraction thereof.

When notified that the corrections have been made, the work or apparatus shall be re-inspected at a charge. Also, when extra inspection trips are necessary due to any reason, a charge of \$50.00 shall be made for each trip, payable prior to re-inspect or partial inspection.

The payment of re-inspection fee shall be made before any further permits will be issued to the person owing the same.

NO PERMIT REQUIRED FOR DEAD TREES, HOWEVER THEY MUST BE VERIFIED BY TREE PROTECTION OFFICER BEFORE REMOVAL.

Request for tree removal permits must include the total number of trees to be reviewed and a detailed explanation for request before field inspection. These trees must be clearly marked with red survey ribbon at 4½ feet above grade adjacent to the tree.

Lots that have no protected trees are subject to a reduction in the amount of permit fee. This reduction shall be 40% less than the above quotes.

Request for land clearing permits shall be charged according to the lot or development size and will take into consideration the percentage of existing tree canopy. Where feasible, a land clearing permit may allow the maximum clearing, grubbing and vegetation removal as deemed allowable under the ordinance and considering the needs of development.

MANGROVE TRIMMING PERMIT

General permits may be issued in accordance to State Statutes and fees shall be based upon the wetland square footage.
