

RESOLUTION NO. 10-06

A RESOLUTION OF THE TOWN OF INDIAN RIVER SHORES IN INDIAN RIVER COUNTY, FLORIDA, ADOPTING THE FINAL LEVY OF AD VALOREM TAXES OF 1.4105 MILS FOR FISCAL YEAR 2010-2011; PROVIDING FOR FUNDING OPERATING EXPENSES DURING FISCAL YEAR 2010-2011; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Indian River Shores of Indian River County, Florida, on September 16, 2010, tentatively adopted the Fiscal Year 2010-2011 Millage Rate following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the Town of Indian River Shores held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Indian River County has been certified by the County Property Appraiser to the Town of Indian River Shores as \$2,507,818,924.

NOW, THEREFORE, BE IT RESOLVED by the Town of Indian River Shores in Indian River County that:

Section I.

The Town Council of the Town of Indian River Shores does hereby adopt the final operating millage rate for FY 2010/2011 commencing October 1, 2010 and ending September 30, 2011 of 1.4105 mils, which is equal to the rolled-back rate.

Section II.


This millage rate of 1.4105 is to fund the operating expenses for Fiscal Year 2010/2011.

Section III.

This Resolution becomes effective immediately upon approval and adoption by the Town Council of Indian River Shores.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF INDIAN RIVER SHORES, FLORIDA, ADOPTING THE FINAL BUDGET FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2010 AND ENDING SEPTEMBER 30, 2011; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Indian River Shores of Indian River County, Florida, on September 16, 2010, tentatively approved the Fiscal Year 2010-2011 budget as presented at a public hearing as required by Florida Statute 200.065; and

WHEREAS, the final budget includes General Fund of \$4,367,369; Roads and Offsite Drainage Fund of \$72,264; Planning, Zoning and Building Fund of \$191,575; and \$331,800 for the Postal Center Fund;

NOW, THEREFORE, BE IT RESOLVED that:


Section I.

Section II.


This Resolution becomes effective immediately upon approval and adoption by the Town Council of Indian River Shores.
